Reply from Michael Russell: The Scottish Government believes that ending free movement of people will have a negative impact on individuals, families and our wider economy and society as a whole.

We have made our position clear during meetings with Home Office and Department for Exiting the European Union counterparts, at both official and Ministerial level. However, we have had no direct and representative role within the UK's negotiation with the EU, despite a written agreement to involve us through meetings of the JMC(EN). Our exclusion from any meaningful influence over the UK negotiating position is unacceptable and I am continuing to press the UK Government to agree a more inclusive approach.

Prime Minister's Questions

Ian Blackford (SNP): Last October, the Prime Minister was forced into a humiliating U-turn on proposals to force companies to disclose how many foreign workers they employed. During the summer, 100 EU nationals resident in the UK received deportation notices in error, which caused alarm to them and many others. We need to cherish those who are here, not chase them away. She must stop dancing to the tune of her right-wing Back Benchers and apologise for the disgraceful treatment her Government have shown migrants in the UK. In the first instance, will she pledge that international students will no longer be included in the net migration figures?

Reply from the Prime Minister: In relation to the error made by the Home Office, every single one of those individuals was telephoned with an apology. It should not have happened in the first place, but the Government did telephone with apologies. As I explained in my first answer to the right hon. Gentleman, however, there is a reason for wanting to control migration. It is because of the impact that net migration can have on people, on access to services and on infrastructure, but crucially also because it often hits those at the lower end of the income scale hardest. I suggest he think about that impact, rather than just standing up here and saying what he has. It is important that we bring in controls, but we want to continue to welcome the brightest and the best here to the UK, and we will continue to do so.

Immigration

Alex Sobel (Labour (Co-op)) [7882] To ask the Secretary of State for the Home Department, with reference to the Supreme Court judgment of 22 February 2017 and her Department's subsequent pause on decision-making on certain settlement applications, (a) how many of those applications are waiting to be processed, (b) what the average amount of time taken to process each application is and (c) what the timetable is for coming to a decision on all of those applications.

Reply from Brandon Lewis: The temporary hold in place on applications with which the Supreme Court judgment was concerned was lifted on 10 August when changes to the Immigration Rules came into effect.

As of 30 June 2017, there were around 5000 such applications on hold which are now being decided in accordance with the new Immigration Rules. We are unable to estimate how long it will take to consider the paused applications as it will depend on the individual circumstances of each case.

Paul Blomfield (Labour) [6714] To ask the Secretary of State for Exiting the European Union, pursuant to the Answer of 12 July 2017 to Question 3555, what period of absence from the UK will constitute a gap in continuous residence for the purpose of obtaining settled status.

Reply from Robin Walker: In line with the current requirements under the Free Movement Directive, a person may be absent for up to 6 months in a year, in order to continue to accrue the five years' continuous residence.

We are prepared to offer flexibility in respect of citizens with strong ties in the UK, for example, students who are studying abroad or workers on an overseas posting if the EU offers similar flexibility on this point.

EU Immigration: Migrant Workers

Paul Blomfield (Labour) [6230] To ask the Secretary of State for Exiting the European Union, with reference to paragraph 6 of his Department's policy paper Safeguarding the position of EU citizens in the UK and UK nationals in the EU, published on 26 June 2017, what rights will be accorded to frontier workers who work in the UK but live in another EU Member State.

Reply from Robin Walker: We want to reach a reciprocal agreement for EU citizens in the UK and UK nationals in the EU as quickly as possible. We have

now held positive and constructive discussions with the European Union on the issue of frontier workers.

We have agreed those qualifying as frontier workers at the day of exit will be included within the final Withdrawal Agreement, in order to protect their ability to continue to live their lives broadly as they do now. The UK will reflect further on what technical definition should be applied in order to categorise a frontier worker and both the UK and the EU will consider how this will work and be applied in practice.

Migrant Workers: EU Nationals

Paul Blomfield (Labour) [6824] To ask the Minister for Women and Equalities, whether she has received evidence of an increase in discrimination against non-UK EU nationals seeking employment because of uncertainty on the future status of such nationals in the UK; and if she will make a statement.

Reply from Nick Gibb: The United Kingdom has a proud record of promoting equality and some of the strongest laws in the world to prevent and tackle discrimination. We will continue to make sure that these rights are protected.

The Government Equalities Office (GEO) is aware of, and is looking into, the reports of discrimination against non-UK EU nationals seeking employment which the hon Member has recently forwarded to the Secretary of State for Exiting the EU. The GEO sponsors the Equality and Human Rights Commission, which has powers to enforce the Equality Act 2010 in cases where it suspects unlawful discrimination in employment may have occurred.

Immigration: EU Nationals

Paul Blomfield (Labour) [6306] To ask the Secretary of State for the Home Department, pursuant to the Answer of 18 July 2017 to Question 4802, how (a) employers, (b) landlords, (c) banks and building societies, (d) the DVLA and (e) benefit agencies will be able to distinguish between EU citizens who arrived in the UK before the specified date and those who arrive after the specified date.

Reply from Brandon Lewis: The Government has set out its intention in its published document “Safeguarding the position of EU citizens living in the UK and UK nationals living in the EU” to issue residence documentation to EU nationals who will be granted indefinite leave to remain on the basis of their residence in the UK. The Government will set out its plans in due course for redesigning the immigration system to introduce controls on future migration to the UK by EU citizens, including any plans for adjusting statutory checks by employers, landlords and other service providers.

Immigration: EU Nationals

The following two questions both received the same answer

Tulip Siddiq (Labour) [5693] To ask the Secretary of State for the Home Department, whether EU nationals who paid £65 for a document to prove permanent residency status will have to pay a fee to apply for settled status.

Tulip Siddiq (Labour) [5694] To ask the Secretary of State for the Home Department, whether those EU nationals who have successfully applied for a permanent residency document will need to apply for the new settled status to remain in the UK.

Reply from Brandon Lewis: As set out clearly in the Government's (Cm 9464) policy paper, free movement rights will come to an end after the UK leaves the EU and therefore cannot be carried forward, as an EU legal right, into the post-exit UK legal regime.

Therefore all EU citizens (and their families) in the UK, regardless of when they arrived, will need to obtain an immigration status in UK law. As set out in the policy paper, EU citizens will be given adequate time to obtain this documentation through a 'grace period' of up to two years.

While EU documentation certifying permanent residence will not be automatically replaced with a grant of settled status, we will seek to make the application process for settled status as streamlined as possible for those who already hold such documents. Fees and charges are being considered as part of the negotiations and in the Government's engagement with stakeholders, but our aim is to keep fees at a reasonable level.

Tulip Siddiq (Labour) [6714] To ask the Secretary of State for the Home Department, whether those EU nationals who have successfully applied for a permanent residency document will need to apply for the new settled status to remain in the UK.

Reply from Brandon Lewis: As set out clearly in the Government's (Cm 9464) policy paper, free movement rights will come to an end after the UK leaves the EU and therefore cannot be carried forward, as an EU legal right, into the post-exit UK legal regime.

Housing: EU Nationals

Helen Hayes (Labour) [6830] To ask the Secretary of State for Communities and Local Government, whether he has received (a) representations or (b) reports on an increase

in discrimination against non-UK EU nationals in respect of access to housing on account of the lack of legal certainty as to the future status of EU citizens in the UK; and if he will make a statement.

Reply from Alok Sharma: My Department has not received any representations or reports raising concerns about discriminations against EU nationals in respect of access to housing.

Our policy paper, “*Safeguarding the position of EU citizens in the UK and UK nationals living in the EU*” published on 26 June, sets out the UK’s fair and serious offer to protect the rights of EU citizens living in the UK. This includes access to social housing for EU nationals.

Refugees: Children

Tommy Sheppard (SNP) [8194] To ask the Secretary of State for the Home Department, with reference to the July 2017 report by Christine Beddoe on separated and unaccompanied minors in Europe, whether the Government plans to create safe travel routes for those minors with a family member in the UK.

Reply from Brandon Lewis: Safe travel routes from unaccompanied children from Europe to the UK are already in place. Our family reunion policy allows a spouse or partner and children under the age of 18 of those granted protection in the UK to join them here, if they formed part of the family unit before the sponsor fled their country.

In addition, the Dublin Regulation allows unaccompanied children who have claimed asylum in another Member State to be transferred here to have their asylum claim assessed if they have a qualifying family member legally present in the UK and transfer would be in their best interests. In order for the Dublin Regulation to apply, an unaccompanied child must first claim asylum in the Member State in which they are located and that Member State must issue a Take Charge Request to the UK. The UK is working closely with other Member States as well as intergovernmental organisations and NGOs to ensure the effective operation of the Dublin Regulation.

Refugees: Children

Tommy Sheppard (SNP) [8195] To ask the Secretary of State for the Home Department, whether officials are working with French authorities to ensure that unaccompanied child refugees in France have information about their legal rights and options.

Reply from Brandon Lewis: UK and French officials are working together to review the processes and procedures in place for the provision of information to children in northern France.

The primary responsibility for unaccompanied children in France lies with the French authorities. The UK cannot operate on the territory of another sovereign nation without a specific request to do so.

Refugees: Children

Jim Cunningham (Labour) [8417] To ask the Secretary of State for the Home Department, how many councils have (a) ended their involvement in the voluntary national transfer scheme to take child refugees and (b) suspended involvement in the Dubs Scheme.

Reply from Brandon Lewis: The National Transfer Scheme was launched on 1 July 2016 and has been working to ensure a fairer allocation of unaccompanied asylum seeking children (UASC) across the UK. A significant number of local authorities have participated in the scheme and enabled the transfer of children away from local authorities with a disproportionate number of UASC in their care. The Government welcomes all offers from local authorities with capacity to look after unaccompanied asylum seeking children. We will continue to engage with local authorities across the country to encourage further participation. The Government will also utilise all offers to fulfil all of our existing commitments including the transfer of children to the UK under section 67 of the Immigration Act 2016.

Reply from Brandon Lewis: The UK's future co-operation with the EU on the area of asylum and migration will be a matter for the negotiations. The UK remains fully committed to co-operation with Member States of the EU on migration and asylum.

Paul Williams (Labour) [8318] To ask the Secretary of State for the Home Department, how many children have been transferred to the UK under the Dublin III Regulation since January 2017; and if she will make a statement.

Reply from Brandon Lewis: The Dublin Regulation allows unaccompanied children who have claimed asylum in another Member State to be transferred here to have their asylum claim assessed if they have a qualifying family member legally present in the UK and transfer would be in their best interests. In order for the Dublin Regulation to apply, an unaccompanied child must first claim asylum in the Member State in which they are located and that Member State must issue a Take Charge Request to the UK.

The Government has committed to publishing regular updates on the number of unaccompanied asylum seeking children transferred to the UK from Europe. This data will be published in the coming months.

UK Parliament Early Day Motions

Gavin Newlands (269) Parliamentarians reporting constituents to the Home Office for deportation – That this House is concerned by recent Freedom of Information reports revealing that on 482 occasions between 2014 and 2016 hon. Members of the House have been informing the Home Office of undocumented migrants; believes that to inform on a constituent would be a fundamental betrayal of trust, acting against the interests of those it is an hon. Member's duty to represent, as well as a failure of confidentiality and a potential breach of the Data Protection Act 1998; is further concerned by the Home Office response that hon. Members would only be identified as an MP if they declared themselves on the form, which allows someone remain anonymous; further believes that the risk that this is but the tip of iceberg; and notes that this information comes amid a year and a decade when the Home Office has been increasingly hostile to those who have chosen to make the UK their home.

Stuart McDonald (293) Immigration detention – That this House welcomes the undercover journalism that led to the harrowing and disturbing footage broadcast during the BBC Panorama programme, Undercover: Britain's Immigration Secrets, on 4 September 2017; urges G4S to fully investigate any and all incidents of abuse and mistreatment by its staff towards people detained at Brook House Immigration Removal Centre; is concerned that the UK remains the only country in Europe not to have a maximum time limit on the length of time an individual can be detained, despite the evidence that indefinite detention has a deleterious impact on the mental health of those detained; notes that in a Written Statement made in response to Stephen Shaw's report into the welfare in detention of vulnerable persons on 14 January 2016, the then Immigration Minister set out a number of reforms that would lead to a reduction in the number of those detained, and the duration of detention before removal, in turn improving the welfare of those detained; further notes that in the year to June 2017, the Government detained 27,819 solely for immigration purposes, and more than 200 were detained for longer than one year; and calls on the Government urgently to implement reform of the use of immigration detention, introducing the introduction of a 28 day time limit and greater use of community-based alternatives to detention.

Gypsy Travellers (Parking Sites)

Stewart Stevenson (SNP): To ask the Scottish Government what information it has regarding the provision by local authorities of parking sites that are suitable for Gypsy Travellers. (S5O-01219)

Reply from the Minister for Local Government and Housing (Kevin Stewart): The provision of Gypsy Traveller sites is a matter for the relevant local authority. The Scottish Government does not routinely collect information concerning sites in Scotland. All Scottish local authorities must, by law, produce local housing strategies that set out their priorities and plans for delivering housing and related services. Those strategies should include plans for meeting any Gypsy Traveller housing needs, including addressing any requirement for provision of suitable sites.

Stewart Stevenson: While noting the particular difficulties in Moray, where Tory part-time MP Douglas Ross was recently a member of the council administration that has failed to provide any such parking sites, does the minister believe that rather than vilifying Travellers—who make a valuable contribution to society—as a “top priority” problem, as he described it, Mr Ross and others in his party should work to address that deficiency?

Reply from Kevin Stewart: Yes, I agree with Mr Stevenson. As I set out in my first answer, the provision of suitable Gypsy Traveller sites in Moray is a matter for Moray Council, based on its local housing strategy. Councillors should look at the needs that are highlighted in their local housing strategy and address the issue accordingly. Gypsy Traveller communities are among those that are most disenfranchised and discriminated against in Scotland. The Scottish Government values the Gypsy Traveller community, the contribution that it makes and the important role that it plays in enriching Scotland socially, culturally and economically. We are committed to tackling all forms of discrimination and to promoting a multicultural society that is based on mutual trust, respect and understanding.

Charter of Fundamental Rights (EU)

Paul Blomfield (Labour) [6712] To ask the Secretary of State for Exiting the European Union, pursuant to the Answer of 20 July 2017 to Question 5540, whether he plans for there to be a free-standing right to equal treatment in UK law once the UK has left the EU.

Reply from Robin Walker: The Charter of Fundamental Rights simply reaffirms rights which already exist in EU law, including the principle that everyone is equal before the law. As EU law and Court of Justice EU case law will be preserved as provided for in the EU (Withdrawal) Bill: it is the Government's intention that the

removal of the Charter from UK law will not affect the substantive rights that individuals already benefit from in the UK, as the Charter was never in itself the source of those rights.

The protections covered in domestic equality legislation, such as the Equality Act 2006, the Equality Act 2010 and equivalent legislation in Northern Ireland, will continue to apply once the UK has left the European Union.
