## Immigration and Asylum

### Scottish Parliament Oral Answers

#### Ukrainian Refugees (MS Ambition)

**Bob Dori (SNP) [S6O-02314]** To ask the Scottish Government what proportion of those previously accommodated on the MS Ambition are now in settled or permanent accommodation.

**Reply from the Cabinet Secretary for Social Justice (Shirley-Anne Somerville):** All guests on the MS Ambition successfully disembarked the ship by the end of March. A great deal of work was undertaken by the Scottish Government, Glasgow City Council and other key partners to support guests into suitable alternative accommodation; I thank partners for their collegiate working on that. We

have not published data specifically on people from the MS Ambition who were matched to accommodation but, since the supersponsor scheme began, about 6,000 individuals have been matched or rematched to accommodation in Scotland, and about half have gone into social or council housing.

**Bob Doris:** The supersponsor scheme is a significant success, but demand for rapid housing is an understandable consequence of it. Some Ukrainians have stayed in temporary accommodation for long periods. Given that it is right for people to move to more permanent accommodation across the country, will the Scottish Government commit to prioritising easier access to the private rented sector in appropriate locations, to give families the space and certainty that they need?

**Reply from Shirley-Anne Somerville:** Bob Doris is correct that welcome accommodation, including ships, is intended to provide an immediate place of sanctuary. Our priority is to settle people into longer-term accommodation. Displaced Ukrainians can find it difficult to access private rented housing; the review of the supersponsor scheme, which was published in November, covered that. The Minister for Housing and I are looking at a range of options, which could include further support, to enhance existing local interventions and help people to access private rented sector housing.

## Scottish Parliament Written Answers

### Illegal Migration Bill

**Foyso Choudhury (Labour) [S6W-18056]** To ask the Scottish Government whether it will provide an update on what discussions it is having with the UK Government regarding tackling human trafficking in Scotland, in light of reports that human rights organisations have claimed that the Illegal Migration Bill will increase the likelihood of human trafficking.

**Reply from Siobhian Brown:** The Scottish Government is clear that the UK Government's cruel and inhumane Illegal Migration Bill should be scrapped immediately. The Bill will cause significant harm to victims of human trafficking. It will facilitate even greater control by perpetrators as a consequence of its provisions which restrict access to vital support and assistance and will likely deter victims from reporting their situation for fear of removal.

The Cabinet Secretary for Constitution, External Affairs and Culture wrote to the UK Minister of State for Immigration on 9 March setting out our position and this was followed by a further letter from the Cabinet Secretary for Social Justice on 25 April. The Scottish Parliament rejected the UK Bill during a debate on 25 April. We set out our intent to lodge a legislative consent memorandum on two clauses within the Bill which alter the executive competence of the Scottish Ministers. We will recommend that Parliament withhold legislative consent to these provisions. We continue to monitor the Bill closely as it is considered by the House of Lords.

### **Prosecutions: Human Trafficking**

**Rachael Hamilton (Conservative)** [S6W-17934] To ask the Scottish Government how many cases of human trafficking have (a) been reported and (b) led to a prosecution, in each financial year since 2007-08.

**Reply from Siobhian Brown:** This information has been placed in the Scottish Parliament Information Centre under BiB No 64215 *[and at the link below]*.

There is no single crime of human trafficking and it may be recoded and prosecuted under the Human Trafficking and Exploitation (Scotland) Act 2015, Criminal Justice (Scotland) Act 2003, Criminal Law (Consolidation) (Scotland) Act 1995, Asylum and Immigration (Treatment of Claimants, etc.) Act 2004.

Table 1 shows crimes related to 'human trafficking' recorded by the police, 2007-08 to 2021-22; Table 2 shows the number of people prosecuted where the main crime/charge was related to human trafficking, 2007-08 to 2020-21.

Please note: Care should be taken when comparing different data sources relating to the criminal justice system. A crime can only be recorded if it is reported to the police and can only then be prosecuted in court if the crime is reported to the procurator fiscal and a decision taken that court proceedings are the most appropriate course of action. In addition, recorded crime statistics count crimes and offences at the time that they came to the attention of Police Scotland, while criminal proceedings statistics report on cases once they have concluded in court. This means that a crime may be recorded by the police in one year and court proceedings concluded in a subsequent year. In addition, a person may be proceeded against for more than one crime, or a set of crimes with more than one victim, in a proceeding, but only a single conviction for the 'main charge' (the one receiving the most severe sentence) would be counted in the court proceedings statistics. There is also the possibility that the crime recorded by the police may be altered in the course of judicial proceedings.

Data for 2020-21 are affected by the pandemic and subsequent court closures and may not be reflective of long term trend.

### **Prosecutions: Human Trafficking**

**Rachael Hamilton (Conservative)** [S6W-17935] To ask the Scottish Government how many outstanding cases of human trafficking have yet to lead to a prosecution due to court backlogs.

**Reply from Siobhian Brown:** The Scottish Government does not hold the requested information.

Any form of human trafficking is completely unacceptable. Through the Victim Centred Approach Fund, we are providing record funding of more than £9 million over the period 1 April 2022 – 31 March 2025 to organisations supporting victims of human trafficking.

We have a strong track record on court investment, and continue to prioritise supporting justice partners to address the backlog.

The 2023-24 budget allocates £42.2 million for justice recovery, which includes over £26 million for the Scottish Courts and Tribunals Service (SCTS) to maintain enhanced court capacity. We have also increased SCTS's resource funding by £5 million, and provided record resource funding for the Crown Office and Procurator Fiscal Service.

## Scottish Parliament Motion

**Kaukab Stewart (SNP)** [S6M-09301] **World Refugee Day and Refugee Week 2023** – That the Parliament marks World Refugee Day on 20 June 2023, and Refugee Week from 19 to 25 June; notes that the theme for Refugee Week’s 25th anniversary is compassion; understands that Refugee Week is the world’s largest arts and culture festival celebrating the contributions, creativity and resilience of refugees and people seeking sanctuary; notes that Refugee Week’s vision is “for refugees and asylum seekers to be able to live safely within inclusive and resilient communities, where they can continue to make a valuable contribution”; considers that the UK Government’s proposed Illegal Migration Bill is dehumanising and immoral and in breach of the UK’s obligations under both the 1951 Refugee Convention and the European Convention on Human Rights; welcomes Scotland’s New Scots approach to support refugees and asylum seekers to integrate into communities from day one of arrival, and notes what it sees as Scotland’s strong commitment to welcoming refugees and asylum seekers who are seeking sanctuary.

## UK Parliament, House of Commons Written Answer: Ukraine

### Dental Services: Refugees

**Rosie Duffield (Labour)** [186458] To ask the Secretary of State for Health and Social Care, what steps his Department is taking to increase access to dental care for Ukrainian refugees.

**Reply from Neil O’Brien:** Ukrainians in the United Kingdom are guaranteed free access to National Health Service healthcare, including screening, vaccinations, mental health support, dental and hospital services. In September 2022 the Government announced ‘Our plan for patients’ which aims to improve patient access to NHS dental care. This includes access for Ukrainians. Information on how to access NHS dental care is outlined in the Welcome Pack provided to all Ukrainian arrivals.

### Naturalisation

**Rachael Maskell (Labour Co-op)** [186130] To ask the Secretary of State for the Home Department, how many applications for naturalisation her Department received in each year since 2010; and what the average processing time was for those applications in each of those years.

**Reply from Robert Jenrick:** The Home Office publishes data on the number of

applications received and the processing of applications for British citizenship on the Gov.uk website. This includes intake and performance against the six-month service standard for completing applications. The most recent Migration Transparency data published in February 2023 shows that 98.4% of straightforward applications were decided within six months.

### **Sudan: Refugees**

**Matt Vickers (Conservative)** [186252] To ask the Secretary of State for Foreign, Commonwealth and Development Affairs, what recent steps his Department has taken to help support UK citizens who have family that are leaving Sudan; and whether his Department plans to take steps to support their safe transportation to the UK.

**Reply from Andrew Mitchell:** Since 25 April, the UK has supported the departure of 2,450 people, including British nationals and dependants out of Sudan. The UK Government continues to provide limited consular assistance to British nationals still in Sudan. Those who have left by alternative means to neighbouring countries are receiving consular support on a case-by-case basis. British nationals who require assistance can call us 24/7. Sudanese nationals who have travelled to a third country and wish to join family members in the UK will need to apply for a visa, if they do not already have the right to enter the UK. ## **UK Parliament, House of Lords Written Answers: Channel Migrants**

### **Undocumented Migrants: English Channel**

**Lord Balfe (Conservative)** [HL7826] To ask His Majesty's Government what arrangements are in place to dispose of boats used to bring illegal migrants across the English Channel; and whether they plan to revisit these arrangements.

**Reply from Lord Murray of Blidworth:** All vessels that have been subject to seizure are held by Border Force until completion of any criminal investigation activities. The majority of boats are not fit for re-sale or to ever go to sea again, as they arrive in very poor condition and may be damaged during the recovery process. The boats are disposed of by Border Force's approved contractors and, where appropriate, any suitable materials are recycled. There are no plans to revisit these arrangements.

### **Asylum: Pregnancy**

**Baroness Sugg (Conservative)** [HL7921] To ask His Majesty's Government how many pregnant women arrived in the UK via small boats in (1) 2021, (2) 2022, and (3) to date in 2023.



**Reply from Lord Murray of Blidworth:** The Home Office ensures that vulnerable small boats arrivals are identified quickly and supported accordingly in line with robust safeguarding processes.

The Home Office has previously established that a total of 77 pregnant women were accommodated at Manston between April and December 2022.

Information about the number of pregnant women that arrived in the UK by small boats in 2021, early 2022, and in 2023 to date is not held in a reportable or readily retrievable format and could also be made available only at a disproportionate cost.

## UK Parliament, House of Lords Written Answers: Other Immigration and Asylum

### Refugees: Resettlement

**Lord German (Liberal Democrat) [HL7906]** To ask His Majesty's Government how many referrals were made by the United Nations High Commissioner for Refugees to (1) the UK Resettlement Scheme, (2) Community Sponsorship, (3) the Mandate Resettlement Scheme, and (4) the Family Reunion Scheme, in each of the past three years; and how many referrals were not accepted in each of those schemes.

**Reply from Lord Murray of Blidworth:** Between 2015 and March 2023, just over half a million people were offered safe and legal routes into the UK. This includes those from Hong Kong, Syria, Afghanistan, and Ukraine, as well as family members of refugees, alongside our global resettlement schemes. The UK continues to welcome refugees and people in need through existing resettlement schemes and is one of the largest recipients of UNHCR referred refugees globally, second only to Sweden in Europe since 2015.

Under these schemes, the UNHCR will refer refugees for resettlement after undertaking an assessment of people's needs and vulnerabilities. The UK does not seek to influence which cases are referred by the UNHCR under these global schemes.

Family Reunion is not referral based. It is an application based route.

## Other UK Parliament and Government

### UK Parliament, House of Commons Written Answer

#### Ministry of Justice: Ethnic Groups

**Peter Gibson (Conservative)** [186410] To ask the Secretary of State for Justice, whether he is taking steps to ensure that the categorisations used by his Department for collecting data on the ethnicity of Gypsy, Traveller and Roma people are consistent with those used by the Office of National Statistics.

**Reply from Mike Freer:** We recognise the importance of more and better data when it comes to tackling disparities, and we have come a long way since the Lammy Review when it comes to monitoring and publishing ethnicity data. We believe the correct approach is to use the detailed 18+1 classification of ethnicity, and this is now adopted throughout the Courts, Prison, and Probation services.

We are continually reviewing how we can improve the collection, distribution, and analysis of ethnicity data in the justice system, and currently we are focusing on ensuring a consistent approach with 18+1 the current standard.

We understand that not everyone will be comfortable or confident about declaring their ethnicity at the point of entry into the justice system. His Majesty's Prison and Probation Service (HMPPS) has therefore developed a Gypsy, Roma and Traveller (GRT) strategy to improve data collection, experiences and outcomes for GRT people in prison.
