## **Scottish Parliament Written Answer**

### **Migrant Workers: Rights and Protections**

**Paul Sweeney (Labour)** [S6W-27834] To ask the Scottish Government what specific consideration it has given to rights and protections for migrant workers as part of efforts to make Scotland "a leading Fair Work Nation by 2025".

**Reply from Kaukab Stewart:** Migrant workers are essential contributors to our communities, public services, and vitally help address skills shortages.

Scotland's Fair Work Action Plan sets out actions to become a leading Fair Work Nation by 2025.

The Scottish Government have funded the Worker Support Centre since 2022 to provide free and confidential support to seasonal migrant workers so that more of them understand their workplace rights and how to exercise them. RSABI (founded as the Royal Scottish Agricultural Benevolent Institution) provides practical, emotional, and financial support to all people involved in the Scottish agricultural industry.

Control over employment and industrial relations legislation is currently reserved to the UK Parliament; while this remains the case, we will continue to use our Fair Work policy to drive up labour market standards for workers across the Scottish labour market.

Maggie Chapman (Green) [S6M-13483] Gypsy Roma and Traveller History Month 2024 – That the Parliament recognises June 2024 as Gypsy Roma and Traveller History Month (GRTHM), an annual observance that began in 2008, which aims to celebrate the communities, histories and cultures of nomadic communities, including Romany Gypsy, Irish Traveller and Roma groups in Scotland and across the UK; believes that, in addition to celebration, GRTHM presents an opportunity to educate and raise awareness of the barriers and issues affecting traditionally nomadic communities; notes that the theme for

2024 is "What does family mean to you?", which, it understands, explores the different shapes and forms that "family" can take, the relationships that people have with each other and the importance of family as a support network; highlights the work undertaken by the UK-wide organisation Friends, Families and Travellers (FFT), which, it understands, is currently drafting a Gypsy and Traveller Election Manifesto; notes the FFT's call for submissions from individuals with Romany, Irish Traveller, Roma, New Traveller, Boater or Showman backgrounds to ensure that the manifesto reflects the needs of the collective community, and wishes all involved every success in promoting inclusivity and acceptance both in 2024 and in the future.

# Racism, Religious Hatred, and Discrimination

#### Scottish Parliament Oral Answers

Hate Crime and Public Order (Scotland) Act 2021 (Implementation)

**Tess White (Conservative):** [S6O-03531] To ask the Scottish Government whether it will provide an update on the implementation of the Hate Crime and Public Order (Scotland) Act 2021 since it came into force on 1 April 2024.

Reply from the Minister for Victims and Community Safety (Siobhian Brown): The Hate Crime and Public Order (Scotland) Act 2021 sends a strong message to victims, perpetrators and communities that offences that are motivated by prejudice will not be tolerated. The act consolidates, maintains and extends protections that are aggravated by prejudice, as well as including stirring up of hatred offences for all characteristics covered in the hate crime legislative framework.

The offence of stirring up racial hatred has been in Scots law since 1986. We have worked closely with Police Scotland and other justice partners to ensure the 2021 act's effective implementation, and we will continue to do so.

**Tess White:** I have been liaising with Police Scotland about engagement with women's groups on the implications of the hate crime act for their lawful meetings. Disappointingly, Police Scotland has indicated to me that it will not participate in that vital engagement while it is in the process of developing longer-term policies around the 2021 act.

Does the minister or the cabinet secretary agree that input from women's groups should

influence the process and should not occur after it has concluded? Will the minister and the cabinet secretary make representations to Police Scotland to ensure that women's voices are heard?

**Reply from Siobhian Brown:** Yes, I agree. We have been told that Police Scotland will consult internally and externally.

**Emma Roddick (SNP):** Police Scotland data shows us that the volume of reports has consistently reduced week on week. Does the cabinet secretary believe that the early high numbers of reports were due to widespread misinformation about the 2021 act, including, unfortunately, from members in the chamber?

**Reply from Siobhian Brown:** Recent Police Scotland data shows that the volume of reports at week 7 has reduced by more than 99 per cent from the first week of the act's commencement. The fact that we have seen so many reports since implementation reinforces the importance of the hate crime act.

Although the commentary surrounding the act during its implementation included misrepresentation, it is important to remember that the act was passed by 82 members of the Parliament. People and communities who are at the sharp end of hatred in their daily lives, simply for being who they are, should rightly look to this Parliament to stand with them, which the Scottish Government will continue to do.

### **Non-crime Hate Incidents (Recording)**

**Murdo Fraser (Conservative)** [S6O-03528] To ask the Scottish Government what discussions it has had with Police Scotland in relation to its guidance on recording noncrime hate incidents.

Reply from the Cabinet Secretary for Justice and Home Affairs (Angela Constance): On 9 May 2024, Police Scotland published its interim guidance on responding to hate crime, which includes information on the recording and handling of non-crime hate incidents. Although the recording of non-crime hate incidents and the development of guidance are operational matters for Police Scotland, the chief constable and I discussed the matter when we met on 30 April.

**Murdo Fraser:** I am aware that, following concerns that I and others raised about the lawfulness of Police Scotland's policy on recording non-crime hate incidents, it has now changed its policy to bring it into line with the Miller judgment. Police Scotland appears to have done so from 1 April, but it took it another five weeks to update its policy and tell anyone that it was changing. Only then was its website updated. Although that change is welcome, what will happen to all the non-crime hate incidents that were recorded under the old policy, which Police Scotland has tacitly accepted was unlawful?

**Reply from Angela Constance:** I reassure Mr Fraser that I have discussed the matter not only with the chief constable; I have also taken the opportunity to discuss it at length with Martyn Evans, the chair of the Scottish Police Authority board, because the SPA has a crucial role in scrutinising Police Scotland operational matters.

Obviously, I take very seriously concerns that are expressed in the chamber. I do not think that Police Scotland would have the same interpretation of what is lawful or unlawful as Mr Fraser has articulated but, given that the detail of the policy is firmly located in an operational space, I will ask the chief constable or the chair of the SPA to reply directly to Mr Fraser on that point.

### **Scottish Parliament Written Answers**

Hate Crime: Lothian

**Miles Briggs (Conservative)** [S6W-27806] To ask the Scottish Government what proportion of hate crime charges or hate crime aggravations have been recorded in Lothian region, to date, under the Hate Crime and Public Order (Scotland) Act 2021.

**Reply from Ruth Charteris:** Crown Office and Procurator Fiscal Service (COPFS) uses a live, operational database to manage the processing of reports submitted to Procurators Fiscal by the police and other reporting agencies throughout Scotland. It is designed to meet business needs in the processing of criminal cases, rather than for statistical purposes and the information within it is structured accordingly. Information provided is at date of extract and may therefore be subject to change as data and systems are updated for operational reasons.

From 1 April to 28 May 2024, 170 hate crime charges and 615 charges with one or more hate crime aggravations in terms of the Hate Crime and Public Order (Scotland) Act 2021 have been reported to COPFS for the whole of Scotland. The total, therefore, is 785 charges.

From 1 April to 28 May 2024, 33 hate crime charges and 98 charges with one or more hate crime aggravations in terms of the Hate Crime and Public Order (Scotland) Act 2021 have been reported to COPFS in the Lothian region. For the purposes of this answer, the 'Lothian region' been restricted to charges reported to COPFS from the Edinburgh and Livingston Sheriff Court Districts. The total 131 hate crime charges and aggravations for Lothian region represents 16.7% of the total for the whole of Scotland.

Non-Crime Hate Incidents: Recording

**Miles Briggs (Conservative)** [S6W-27429] To ask the Scottish Government, further to the answer to the third supplementary to question S6O-03335 by Angela Constance on 24 April 2024, whether it can confirm if any non-crime hate incidents recorded by Police Scotland under the Hate Crime and Public Order (Scotland) Act 2021 will appear in any (a) disclosure and barring service check, (b) security clearance check, including a developed vetting check and (c) database check by (i) a serving officer or civil employee of Police Scotland and (ii) an employee of Disclosure Scotland, including an informal inquiry carried out with regard to current or potential employment.

**Miles Briggs (Conservative)** [S6W-27430] To ask the Scottish Government what its position is on whether the recording of non-crime hate incidents under the Hate Crime and Public Order (Scotland) Act 2021 could have a material effect on an individual's employment or otherwise personal circumstances.

Reply from Siobhian Brown: In the Interim guidance published for officers on the recording of Non-Crime Hate Incidents - Police Scotland published by Police Scotland on 9 May 2024, it explains that the alleged perpetrator would usually be recorded as the 'other party' (unless in exceptional circumstances where there is real risk of harm or future criminal offence). When asked at the Scottish Police Authority Board Meeting on Thursday 23 May 2024 if detail on the 'other party' would appear on a Disclosure check, Deputy Chief Constable Alan Spiers provided reassurance that it would not.

In rare cases, Disclosure Scotland may receive other relevant information (ORI) from relevant police forces (including forces in England, Wales and Northern Ireland) when someone applies to join the PVG scheme, the ongoing monitoring of scheme members, or for an enhanced disclosure check.

ORI is used across the UK, with the UK Government having their own guidance to the police for the handling and processing of non-crime hate incidents in relation to disclosure checks. ORI about the applicant or scheme member can only be provided where the chief officer of a relevant police force reasonably believes it is relevant for the specific purpose of the disclosure and ought to be included on the disclosure certificate. The inclusion of any information Scottish police may hold on an individual is a decision for Police Scotland to make with regard to the statutory Guidance for the Chief Constable of Police Scotland.

Disclosure Scotland staff do not have access to the database on which non-crime hate incidents are recorded.

# The following two questions both received the same answer Non-Crime Hate Incidents: Recording

**Miles Briggs (Conservative)** [S6W-27431] To ask the Scottish Government, in light of the recently published Police Scotland interim guidance on the recording of non-crime hate incidents (NCHIs), whether any process, such as arbitration, exists that would allow a person to appeal a decision that an incident has met the threshold for being recorded as a NCHI, or whether a person's only recourse would be to pursue a civil action in order to seek to have the NCHI expunged from the record.

**Miles Briggs (Conservative)** [S6W-27656] To ask the Scottish Government, in light of the recently published Police Scotland interim guidance on the recording of non-crime hate incidents (NCHIs), which states that a report would happen in "exceptional circumstances", what are defined as "exceptional circumstances" in which a party allegedly at fault in a reported incident could have their details recorded.

**Reply from Siobhian Brown:** The recording of non-crime hate incidents (NCHIs) is an operational matter for Police Scotland. This preserves the operational independence of Scotland's criminal justice system and keeps it free from political interference.

# The following two questions both received the same answer

### Non-Crime Hate Incidents: Recording

**Miles Briggs (Conservative)** [S6W-27432] To ask the Scottish Government what data destruction methods and processes Police Scotland would employ to delete any recorded non-crime hate incident where it had been found not to have met the threshold for being so recorded.

**Miles Briggs (Conservative)** [S6W-27657] To ask the Scottish Government in what system Police Scotland is currently mandated to record non-crime hate incidents; whether this is a distinctly different system to the system for recording arrest records or formal charges, and, if this is not the case, whether there are strict Chinese wall protocols in place to mitigate the risk of deliberate or accidental disclosure.

**Reply from Siobhian Brown:** Methods and processes with respect to handling of data on non-crime hate incidents recorded by Police Scotland, is an operational matter for Police Scotland.

### Non-Crime Hate Incidents: Liability for Public Knowledge

**Miles Briggs (Conservative)** [S6W-27433] To ask the Scottish Government what its position is on whether (a) it and (b) Police Scotland could be liable for any material effect to a Scottish resident's circumstances if it was found that any negligence or malice on the part of a public servant had led to public knowledge of a recorded non-crime hate incident.

**Siobhian Brown:** Any investigation into whether there has been any material effect to a Scottish resident's circumstances due to alleged negligence or malice on the part of a public servant leading to public knowledge of a recorded non-crime hate incident, and related issues of potential liability, would be dealt with on a case by case basis.

**Reply from Siobhian Brown:** There are no reporting requirements on the rate and nature of non-crime hate incidents from Police Scotland to the Scottish Government. The Scottish Government is not aware of reporting requirements to any other public body.

**Miles Briggs (Conservative)** [S6W-27666] To ask the Scottish Government whether it (a) requires and (b) conducts formal security clearances for anyone designated as a (i) "hate crime advisor" and (ii) "hate crime champion", as set out in the document, Interim Guidance - Responding to Hate.

**Reply from Siobhian Brown:** The designation of a Hate Crime Advisor and Hate Crime Champion is an operational decision for Police Scotland, and the Scottish Government does not hold this information.
