Baroness Deech (Crossbench) [HL7432] To ask His Majesty's Government, further to the written answer by Baroness Scott of Bybrook on 21 April (HL6913) relating to the UK Holocaust Memorial and Learning Centre, whether they will set out the measurement in square metres of each of the items (a) to (g) in item 9 of the table included in that answer.

Baroness Scott of Bybrook: The measurements for the items in 9) are:

Area to be enclosed to ensure the security of the Centre		1412 m ²

The parts of the mound not accessible to the public (fins and ha-ha)	153 m ²	
Service elements of café building		17 m ²
Total surface area to be occupied by Holocaust Memorial and Learning Centre		1429 m ²
